PURPOSE

The EU – Connecting Europe Facility (CEF) is a key EU funding instrument in delivering the European Green Deal and an important enabler towards the Union's decarbonization objectives for 2030 and 2050. It is focused on the development of sustainable, high performing, and efficiently interconnected trans-European networks covering three different sectors: Transport, Energy, and Digital services.

The CEF Transport program aims to support investments in building new transport infrastructure in Europe or rehabilitating and upgrading the existing one. The CEF Transport program follows the Trans-European Networks for Transport (TEN-T) policy, which focuses on planning and developing a coherent, efficient, multimodal, and high-quality transport infrastructure across the EU. The TEN-T network is formed by nine European Transport Corridors and two horizontal priorities.

The CEF Transport supports innovation in the transport system in order to improve the use of infrastructure, reduce the environmental impact of transport, enhance energy efficiency and increase safety. The CEF budget is allocated for three envelopes: the general, the cohesion, and the military envelope.

PROJECT TYPES

CEF Transport supports co-funding for two main project types:

 Studies: These include preparatory activities necessary for implementing projects, such as technical studies, mapping, and feasibility assessments. These studies are essential for identifying potential risks and determining the feasibility of a project.



 Works: These encompass the construction and implementation phases, involving activities such as procurement, installation, and deployment to operationalize the infrastructure

The calls cover the core, extended core and comprehensive TEN-T networks in the following areas:

- Railways
- Inland Waterways (IWWs)
- · Maritime and inland ports
- Road safety
- Multimodal freight terminals
- Multimodal passenger hubs

- Safe and secure mobility
- Infrastructure resilience

- Part B: Proposal's technical content. Download the mandatory word template, fill it and upload it as a PDF file.

 - Cost-Benefit Analysis (CBA)


